1. Unless otherwise stated, the client is in charge of the music selection and/or special music numbers and the order of events. This will be submitted in writing at least 2 weeks before the function. Last minute changes will be accommodated by Songman Entertainment if time permits.
2. The client agrees to provide a sufficient electrical power supply out let within 50 feet of the designated disc jockey's setup location.
3. If the setup location is outside, the client agrees to provide adequate shelter to protect the equipment from adverse weather conditions or from summer heat.
4. Songman Entertainment does not guarantee the availability of the disc jockey beyond the contracted time.
5. The client agrees to pay \$100 non-refundable deposit to reserve his/her event date. Songman Entertainment holds reservations made by for 10 days to allow shipping time of the deposit and signed contract. Failure to respond within 10 days may result in cancellation.
6. The remaining balance is due and payable upon ARRIVAL of the designated mobile disc jockey. Payments made after the event date are subject to a late charge of \$50. If function should extend past contracted time (shown above) \$100 per hour will be due by cash or check at the end of the function. If client decides to end the function earlier than the contracted time, the original contracted price stands.
7. Delinquent payments and/or all past due accounts shall accrue interest at the rate of 1.5% month.
8. Client agrees to be liable for returned checks, in addition to any late charges or interest. A \$30 non-sufficient funds charge will be imposed for each returned check.
9. The client accepts full liability for all damages to any equipment in the possession of the designated disc jockey that occur as a result of intentional or unintentional action, or neglect upon the part of the client or his/her guests, patrons, customers, students, etc. In order to prevent liability resulting from an accidental injury to any individual attending this performance, Songman Entertainment reserves the right to deny any guest access to the sound system, cd's, records, cassettes, and supplies owned or leased by the disc jockey. In the event the disc jockey believes an unsafe situation exists, he may call upon the client to remedy the situation. If no action is taken, the disc jockey may cease operation until situation is resolved. The client is still responsible for payment in full.
10. Songman Entertainment will not be held liable for unavoidable detention by conditions or acts of God legitimately beyond control of the designated DJ.
11. In the unlikely event that the disc jockey is unable to perform at the event, and a replacement cannot be found, Songman Entertainment will make a full refund of any deposits or payments made by the client. The client agrees that the refund will be the full extent of damages that he/she is entitled to, and no further damages may be sought against Songman Entertainment.
12. The DJ will not be held liable for any damage or harm to property or persons, unless such is caused by gross or wanton negligence on the part of the DJ.
13. If litigation for any item in this contract agreement is necessary for collection, Songman Entertainment shall be entitled to all reasonable attorney fees, court costs, and collection expenses.
14. SEVERABILITY: The invalidity of any provision of this Agreement shall not affect the validity of any other provision.
